There is still a need to strengthen the capacities of CSOs, especially at the barangay level (Jobe C. Tubigon, Executive Director, KDFI)	Emphasized during the implementation of capacity development programs for CSOs the independence of their selection of representatives to the barangay-based institutions and local special bodies.
2. BBIs welfare and benefit packages, the long over-due passage of the Magna Carta for the Barangay Officials and Functionaries (PB Guiling Preglo LnB President, Sulop Chapter)	It is timely to advocate and lobby for the adoption of the Magna Carta for Barangays to support and strengthen the barangays and improve service delivery (Dir. Gary R. Governance Program

The multi-sectoral representatives who were selected as panelists raised major issues and concerns. The issues and concerns were processed during the Pre-Dagyaw Focus Group Discussion and were also discussed in the NGA briefer which was submitted to the DILG PMO XI before the actual conduct of the Dagyaw Town Hall meeting.

6 members of CSO Panelists were allowed to interface with senior Cabinet Officials from the DILG Central Office, DBM Region XI, and Mindanao Development Authority.

There were 1,418 participants from various sectors and Barangay Functionaires flocked to City Gymnasium of Digos, Davao del Sur in support of the call for the passage of the MAGNA CARTA FOR THE BARANGAYS as highlighted Topic discussion for the Dagyaw 2024 Open Government and Participatory Governance Regional Town Hall Meetings.

The activity is envisioned to be one of the government's strategies in providing avenues for productive, valuable, sincere, and visible engagement between the government and the people at the local levels.

Dagyaw 2024 is one way of bringing the government closer to the people through Civil Society Organizations and citizens in addressing various issues and concerns through national and regional officials of government agencies.

Among the key issues that surfaced during the dialogue were the highly politicized selection of CSOs in the Barangay Based Institutions; BBIs welfare and benefit packages, the long overdue passage of the Magna Carta for the Barangay Officials and Functionaries, the issue on lack of inclusivity in the selection of the members of Peoples Councils, discrimination in the accreditation process at the city and municipal levels, and the issue on the localization of the establishments of Peoples Councils and the conflicting roles between the atter and the Local Special Bodies, the high inflation which resulted to high prices of basic commodities, support programs to local farmers, less responsive LGU Officials to the Localization of 4Ps Program (Graduated Beneficiaries avails Sustainable livelihood Support) and the need for some local government units to prioritize installation of water system facilities which the concerned resource persons reaffirms their commitment to bring all of these issues to the national leadership and engage the lawmakers in crafting meaning structural and policy reforms in order to strengthen and ensure more inclusive participation at the barangay levels.

SLGP PMO Richard Villacorte said that through open government and participatory governance, the citizens can actively participate in good governance, especially in Davao del Sur likewise highlighted the need to bring the government closer to the people. "Our task here is to gather all your stories and take them to desks where programs and decisions are made. It is here in the town halls where questions are to be answered," SLGP PMO Manager said.

DILG Assistant Secretary Lilian M. De Leon said "Dagyaw is in line with the desire to finally put an end to the 50-year-long insurgency and sustain the gains of an insurgency-free Davao del





Sur and ultimately to the entire Davao Region through the whole-of-nation approach Dagyaw Townhalls want to showcase to our people that the government is doing not just 'something' but 'everything' for the general welfare of our people."
